



Chapter Services Committee Chair: Daniel Studdard, AICP


The Chapter Services Committee supports the development of GPA communication tools including gathering articles and information of interest to the Chapter membership. The Committee seeks exciting activities to promote and maintain Chapter membership amongst professional planners, planning commissioners, and others actively involved in the field of planning in Georgia and promote interest in the field of planning and Chapter membership among college students and potential new members to grow the GPA roster.

Policy and Advocacy Committee Chair: Michael Kray

The Committee will develop and carry out a policy and advocacy program that represents the views of the membership, and that is approved by the Board of Directors. The Committee will work with the Vice President for Programs and the Programs Committee in an effort to hold at least one legislative forum annually as may be appropriate, to which all members are invited, for the purpose of developing Chapter priorities on legislative issues and recommend position statements as necessary for Board approval. The Committee will support the GPA's communication tools with information on policy issues, proposed legislation, and results of the legislative process in Congress and the Georgia General Assembly.

Programs Committee Chair: Allison Stewart-Harris, AICP

The Programs Committee, either directly or through sub-committees, shall be responsible for creating and executing all membership meetings and conference as to date, time, place and program content and presenters, means and refreshments, etc. The Committee will encourage and execute special Chapter events such as local 'Planners Luncheons," receptions, and other educational events. The Programs Committee along with the Board of Directors will coordinate Chapter awards, including the solicitation and review of nominations and the distribution of awards.





Michael R. Boswell, Ph.D., AICP

Michael R. Boswell is Department Head and Professor of City & Regional Planning at California Polytechnic State University (Cal Poly) in San Luis Obispo. He has a Master of Science (M.S.P.) and Ph.D. in Urban & Regional Planning from The Florida State University. He has published on topics such as climate action planning, hazard mitigation, adaptive management and governance, local government planning, autonomous vehicles, and sustainable development. He is lead author of the book Local Climate Action Planning published by Island Press. Dr. Boswell served as an expert advisor on 'Guiding Principles for City Climate Action Planning' for the UN-Habitat Cities and Climate Change Initiative and attended the UN Climate Change Conference in Paris (COP-21) to launch the report. In 2017, he represented the Association of Collegiate Schools of Planning in the Planners for Climate Action initiative launched at COP-23 in Bonn. Since 2006 he has served as a senior advisor, and currently serves as Project Director, for the California Multi-Hazard Mitigation Plan update. He is a founding member and served on

the Organizing Committee of the Central Coast Climate Collaborative and he is the Director of the California Climate Action Planning Conference. Dr. Boswell worked as a professional planner for Brevard County, Florida, the East Central Florida Regional Planning Council, and the Florida Department of Environmental Protection. His public service leadership includes having served on the board of the San Luis Obispo County Bicycle Coalition and as a member and Chair of the City of San Luis Obispo Planning Commission.






