REGISTRATION FEE

LOCATION

The Winter 2022 Georgia Association of Zoning Administrators Conference will be held at the University of Georgia Center for Continuing Education & Hotel at 1197 South Lumpkin St., Athens, GA 30602.

LODGING

For your convenience, a block of rooms is being held for your event at the Georgia Center's UGA Hotel and Conference Center until January 25, 2022. The conference guest room rates range from \$109.00 to \$154.00 dependent upon room type per night plus sales taxes. Lodging is limited; please call early to secure your lodging needs. When the block closes or all rooms are booked, whichever comes first, the special rate may not be honored, and room availability cannot be assured. Session A: The Basics of Zoning

Chrissy Marlowe, Faculty, Carl Vinson Institute of Government

Chrissy Marlowe, a community planner who has worked with local government in planning, zoning, and historic preservation for over 25 years, will provide information and discussion on the basics of planning & zoning that every staff member, appointed board member, and elected official needs to know to be an effective local community leader. Example case studies will be given in which participants will discuss how they would approach decision-making in rezoning, conditional/special use cases, and/or variances.

Session B: Advanced Zoning

Josh Campbell, Director, Planning and Inspections Department, City of Suwanee

Josh Campbell, an experienced planner, will provide information and discussion of ways that experienced planning & zoning officials can help their communities advance and evolve, make the best and most informed decisions on challenging and controversial zoning applications, and complete projects to help communities succeed with quality growth and redevelopment. Example case studies will be given in which participants will discuss how they would approach decision-making in projects, zoning applications, and other matters.

Adam Nelson, Partner, Fleming & Nelson, LLP

This session will be led by Adam Nelson, a partner in Fleming & Nelson, LLP, a law firm that specializes in local government representation. While serving as general counsel for over 10 local government entities, Adam has participated in numerous formal and informal mediations, and has specifically assisted in resolving disputes arising from zoning matters. This session will include a presentation on useful strategies and techniques that may be employed to resolve inherent conflicts between developers, adjacent landowners, elected and appointed officials, and staff members. We will also focus on fostering relationships with interested stakeholders and community members in an effort to deescalate charged situations. By discussing real world examples, the intention of this session is to equip staff to be able to serve as a line of communication between political actors, developers, and taxpayer citizens impacted by those developments.

This session will provide information and discussion about what happens with a proposed development after a rezoning, conditional/special use, and/or variance is approved. Speakers will discuss the standards and perspectives of the reviewers, whether zoning, engineering, fire marshal, utilities, or otherwise. In addition, the perspectives of the applicant's representatives will be discussed. Particular emphasis will be made on site review, including but not limited to erosion control (ES&P), floodplain management, and stormwater management. Speakers will give the example of one local government's process and discussion will include how it may be similar to or different from other local communities.


