## Who we are

The Georgia Planning Memorial Foundation is an independent non-profit 501(c)(3) corporation.

It was initially organized by the Georgia Planning Association (a chapter of the American Planning Association) in response to a flood of donations received in memory of Denise Abboud after her tragic and untimely death in 2007.

The GPA Board of Directors created the Denise Abboud Memorial Fund to honor Denise's ideals and contributions to the planning profession during her life.

Subsequently, the GPA Board sponsored the creation of the Foundation as a non-profit corporation to administer the Denise Abboud Fund and other donations received in honor of other fallen comrades.

## What we do

The Foundation provides grants through the Denise Abboud Fund, which was created to help with the education and ongoing professional development of planners, planning commissioners or other persons in Georgia, who work in or serve cities and counties in an official planning role.

Grant assistance generally helps recipients with travel expenses to obtain training at workshops and conferences, such as the GPA Annual Conference and DCA's Community Planning Institute.
