CPA provides planners and decision makers with tools to make effective decisions regarding their community's future. CPA is open to planning officials across the state.

The Community Choices Online Resource Center is designed to assist in accessing timely, high-quality information about community planning and quality growth — quickly and easily. It can help enable elected officials, practioners, appointed citizen planners and other community leaders to learn — both from each other and from communities across the country — about implementing innovative community planning concepts.
