

- Maintains a regional perspective and devotes 1/3 of the plan to detailing implementation measures and the accountable party






Outstanding Planning Document Large Community - Honorable Mention

- Citizen support for implementation reflected in passage of SPLOST



One Town, One Goal, Thomaston Mill Neighborhood


- Represents public/private initiative to revitalize neighborhoods in Griffin and Spalding County

GPMF NEWS

2009 was a banner year for the Georgia Planning Memorial Foundation!

Created in 2008 with an endowment donated by generous friends and colleagues in the memory of Denise Bonotto Abboud, fundraising through the annual auction at the past two GPA conferences generated a total of more than \$6,500 in available grant monies. These funds enabled the Foundation, through the Denise Abboud Fund, to make grants available for the 2009 GPA Conference and to continue grant funding into 2010. The 2009 grant program focused on offsetting travel expenses for planners who serve eligible cities and counties to attend the GPA Annual Conference in Athens, and the GPA Board generously agreed to waive the conference registration fee for recipients that were GPA members.

Also in 2009, the Board of Directors of the Foundation was expanded numerically and geographically with the addition of three new members: **Brian Shuler**, AICP (Colquitt County Administrator), **Daryll Simmons** (Kennesaw Planning Director) and **Tom Couch**, AICP (Bulloch County Manager).

of StreetSmarts and Urban Collage) put together a killer display panel for the GPA conference, and a beautiful hand-out brochure, with information on the Denise Abboud Fund. Steve Cover, an accomplished auctioneer (who knew!?), performed yeoman's service leading our Annual Fundraising Auction at the last GPA Conference to a resounding success. Steve is now with HOK in Atlanta. And, as always, the Foundation especially thanks the many individuals and companies that open their hearts each year with donations that make our auctions so successful.
